The Standing Committee constituted by University Grants Commission, in its meeting held on 31.07.2019 decided to grant autonomous status to Haldia Institute of Technology, ICARE Complex, HIT Campus, PO Hit, Haldia dist., Purba, Medinipur, West Bengal-721 657 affiliated to Maulana Abul Kalam Azad University of Technology, Calcutta for a period of ten years w.e.f. 2019-2020 to 2028-2029.



The above Autonomous Status is issued subject to fulfillment of the following terms and conditions :

1. That the deficiencies/suggestions (if any) as pointed out by the UGC Committee in their report shall have to be removed/implemented (respectively) as early as possible by the College authority.
2. That the admissions in courses are to be made strictly in accordance with the yearly affiliation letter as will be issued every year by this university.
3. That the admission, registration etc. shall be made in accordance with the regulations notified by this university from time to time.
4. That issuance of no excess marksheets/certificate beyond admission/university-registration shall be made by the college under any circumstances.
5. That the college shall operate only from the above approved location.

That this university may paid special visits observing the maintenance of quality of education. In case of non-compliance resulting sharp decline in standards and/or quality and/or guidelines in the autonomous college, it shall be open to this university to revoke the autonomous status of the college and accordingly UGC would be informed.

The college has to submit Rs. 10,00,000/- at this university as Autonomy Fee for 2019-2020 to 2028-2029.
